

If a CSFP applicant is participating in one of the federal or state programs listed below, they would be eligible for CSFP, even if their income is over the existing income guidelines. An applicant must still meet other existing CSFP guidelines to qualify (60+, live within SHH Service Area, and not living in a residential facility that provides meals, such as nursing home or assisted living facility).

<b>Dual-Eligibility Program List</b>	<b>Program Details</b>
<b><i>Federal Programs</i></b>	
Supplemental Nutrition Assistance Program (SNAP)	Benefits for food put on an electronic bank transfer (EBT) card monthly. Formerly known as food stamps.
Supplemental Security Insurance (SSI)	Monthly benefits paid to individuals with low income and limited resources who are blind, 65 and older, or who have a qualifying disability.
Food Distribution Program on Indian Reservations (FDPIR)	A program that distributes USDA foods to income-qualified households living on Native American/Indian Reservations
Low-Income Subsidy Program (LIS)	A program that helps people with Medicare pay for prescription drugs. This is also known as “Extra-Help”.
Medicare Savings Program	Helps people with limited income and savings pay for Medicare costs.
<b><i>State Programs</i></b>	
Minnesota Care (MN Care)	A health care program for low-income individuals in MN
Medical Assistance (MA)	Minnesota’s Medicaid program for low-income individuals
Minnesota Supplemental Aid (MSA) or MSA Housing Assistance	Cash assistance for adults who receive SSI to pay for basic needs. Select adults who don’t receive SSI may also qualify.
Minnesota Family Investment Program (MFIP)	Cash and food assistance for families with children, where caregivers are working.
Women, Infants, and Children Supplemental Food Program (WIC)	Supplemental nutrition program for eligible pregnant women, new mothers, babies, and young children.
Public Housing	Rental housing for people with low-income that is owned and managed by public housing authorities (PHA)
